This festival will provide the opportunity for school bands to perform in a prelim/finals venue. (Something which many small schools do not have the opportunity to do because of school size)

Eligibility

The Competition is open to 1A, 2A, and 3A high school bands. CBA rules of eligibility apply.

Contest Format

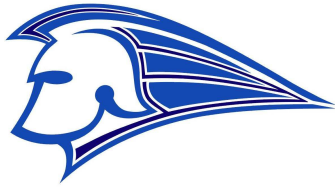
